
Dear Mr. D'Alessandro:

Enclosed please find the FY18-27 STIP Application Cover Sheet along with the Project Prioritization list from the City of East Providence. Much of the project and respective priorities remain the same from last year's STIP application. The highest priority project on the list continues to be pavement resurfacing and sidewalk replacement along one of the City's busiest traffic corridors, Pawtucket Avenue, from Veterans Memorial Parkway to Waterman Avenue (STIP ID 9525).

Additionally, though not on the current list of projects, the City continues to pursue the I-195 Interchange Project for Taunton Avenue, Warren Avenue, and Waterfront Drive. This critical transportation improvement project was previously on the STIP, it is presently at the 10% design phase and approximately \$5 million in federal earmark funds remain for this project. The need for this project is greater than ever, given the recent development and investment along the City's waterfront. The potential for additional development opportunities with the construction of a new interchange would make this area one of the largest economic development projects in the State.

We look forward to working with the Statewide Planning Program and the RI Department of Transportation on these most important transportation improvement projects. Thank you for your consideration.


