2023 Legislative Session Wrap-up



Here is a short summary of some of the bills passed by the General Assembly (and signed by the Governor) that will affect municipal planners.

H 6085 SUB A/S 1033 SUB A - Amends the Comprehensive Plan Act:

- Requires a comprehensive plan's implementation program to include a five-year "strategic plan."
- Planning boards must submit an annual report that summarizes the status of implementation of the strategic plan to their city or town council, which then must be reviewed by the council at a public meeting.
- A comp plan that is more than twelve years out of date cannot be used to deny a land use decision.
- Takes effect on March 1, 2024.

H 6059 SUB A/S 1032 SUB A - Amends the Zoning Enabling Act:

- Allows lots substandard in area to have reduced dimensional requirements in proportion to the degree of non-conformity.
- Requires specific and objective criteria for each use allowed by special use permit or the use is deemed to be a use by right.
- Takes effect on January 1, 2024.

<u>H 6061 SUB A</u>aa/<u>S 1034 SUB A</u> – Amends sections of the Subdivision Enabling Act: <u>Minor Subdivisions:</u>

- A minor subdivision is now nine lots or fewer;
- Applications that do not require zoning relief and meet all the applicable requirements are reviewed and approved administratively; administrative waivers are a local decision.
- An application requiring dimensional relief or street creation requires a public hearing; Preliminary plan is reviewed and approved by the Planning Board.
 - Unified Development Review is required.
- Final review is administrative.

2020 Census Update

The U.S. Census Bureau has released the 2020 Census Demographic Profile and Demographic and Housing Characteristics File (DHC).

These products provide the next round of data available from the 2020 Census, adding more detail to the population counts and basic demographic and housing

statistics previously released redistricting and apportionment purposes. This release contains more detailed age groups, the first data available on sex from the 2020 Census, information on families and households, and more detail on housing. They also show the intersection of many of these topics by race and Hispanic origin. The <u>Demographic Profile</u> provides an overview of the topics covered in the 2020 Census in one, easy-to-reference table for geographies down to the tract level.

The DHC provides <u>more detailed tables</u> at the National, State and County Subdivision level of geography showing Median Age by Sex, and how the median age in Rhode Island is 40.5, slightly higher than the 38.8 median age of the U.S. The municipality in Rhode Island with the highest median age per the 2020 Census was Jamestown, at 55.4. The Demographic Profile and many of the DHC tables are also available for census tracts, block groups, blocks and ZIP Code Tabulation Areas.

We will be developing Census briefs, reports and data visualizations analyzing the 2020 Census Demographic Profile and Demographic and Housing Characteristics data products over the course of the next several months. July 6 <u>NEA Grants for Arts</u> provides comprehensive and expansive funding opportunities for communities supports opportunities for public engagement with the arts and arts education.

July 7 NAWCA U.S. Standard Grants- Department of the Interior Fish and Wildlife Service supports public-private partnerships carrying out projects that further the goals of the North American Wetlands Conservation Act.

August 17 NRCS Regional Conservation Partnership Program co-invests with partners to implement projects that generate conservation benefits by addressing specific natural resource objectives.

August 18 PROTECT Discretionary Grant Program funds projects that address the climate crisis by improving the resilience of the surface transportation system, including highways, public transportation, ports, and intercity passenger rail.

August 21 <u>Climate Resilience Regional Challenge (NOAA)</u> will support collaborative approaches to achieving resilience in coastal regions with an emphasis on risk reduction, regional collaboration, equity, and building enduring capacity.

August 21 <u>Multimodal Project Discretionary Grant</u> deadline for three U.S. DOT programs for surface transportation infrastructure: National Infrastructure Project Assistance (Mega), Nationally Significant Multimodal Freight and Highways Projects (INFRA), and Rural Surface Transportation Grant (RURAL).
