September is National Preparedness Month



<u>National Preparedness Month</u> was created to raise awareness about the importance of preparing for disasters and emergencies and to remind Americans to be ready for any natural or man-made disaster that could affect them, their homes, communities, or businesses. The month aims to reduce the impact of emergencies by reminding everyone to be prepared.

Remember, the time to take these actions is not when a disaster is at your door: at that point, it's too late! Things to do now to be

prepared include:

- Sig up for <u>emergency alerts</u> in your area to receive life-saving information and download apps like the <u>American Red Cross emergency app;</u>
- Store important phone numbers somewhere else besides your cell phone;
- Store important documents and items like passports, birth certificates, and electronics in resealable water-tight plastic bags in a flood-safe place, like a high shelf or upper floor;
- Sign up for direct deposit and electronic banking so you can access funds and make electronic payments;
- Create an emergency kit;

September 8 Deadline to submit comments on <u>proposed amendments</u> to Rhode Island's Low Emission Vehicle Program (250-RICR-120-05-37).

September 8 <u>Southeast New England Program (SNEP) Network Stormwater Planning</u> <u>Series</u> deadline for free training and technical assistance to develop a conceptual design for a nature-based stormwater retrofit in local communities.

September 10 <u>Refuges Enhancement/Infrastructure grants</u> enable communities to increase outdoor recreation opportunities and be more deliberate in using partnerships to help the U.S. Fish & Wildlife Service address infrastructure repair and improvement.

September 14 <u>Climate Smart Humanities Organizations program</u> supports comprehensive assessment and strategic planning by humanities organizations to mitigate physical/operational environmental impacts and adapt to a changing climate.

September 28 <u>Reconnecting Communities and Neighborhoods Program</u> will assist economically disadvantaged/undeserved communities with planning, construction, and regional partnerships to restore connectivity through the removal, mitigation or replacement of highways, roadways, or other infrastructure.

September 28 <u>Rural and Tribal Assistance Pilot Program</u> is a first-come, first-served, no-match grant program with the goal of funding early-stage development assistance for rural and tribal infrastructure projects.

September 30 <u>Energy Future Grants</u> will enhance energy affordable and access, ensuring the benefits of a clean energy economy flow to disadvantaged communities.

September 30 <u>Rural Energy for America Program (REAP)</u>helps agricultural producers and rural small businesses reduce energy costs and consumption and helps meet the nation's critical energy needs.

September 30 <u>U.S. Fish and Wildlife Service Coastal Program</u> provides assistance to coastal communities, conservation partners, and landowners to restore and protect fish and wildlife habitat on public and private lands.

October 15 <u>**RIDOT**</u> <u>**Municipal**</u> <u>**Road**</u> **&** <u>**Bridge**</u> <u>**Program**</u> provides funding to municipalities for the construction and maintenance of roads, sidewalks, and bridges.

October 27 <u>**RIDEM Open Space Grant program**</u> provides up to fifty percent matching funds to municipalities, land trusts, and non-profit conservation land organizations to

preserve open space throughout the state.
