### ***Housing 2030: Building Rhode Island's Future***

In accordance with the Rhode Island General Laws, § 42-11-10 and Chapter 42-35, the State Planning Council is reviewing *Housing 2030* for adoption as a State Guide Plan Element. *Housing 2030* provides State goals, objectives, and policies, along with implementation actions for guiding both public and private spheres when dealing with matters of housing. In addition, as an element of the State Guide Plan, *Housing 2030* will require the consistency of municipal comprehensive plans and publicly supported projects and activities.

Notice is hereby given that a public hearing will be held on the adoption of this plan, at which all persons interested will have an opportunity to comment. There will be a brief informational presentation about the plan, followed by the opportunity to comment. The hearing will take place at the following date and time:
