

We'll be meeting *in person* at the East Providence Public Library, 41 Grove Ave. in the community room. (And maybe add a happy hour outing afterward??)





Grant Opportunities

September 13 Areas of Persistent Poverty Program deadline. The Federal Transit Administration (FTA) announces \$16.3 million in competitive grants to support projects that will improve transit services or facilities in areas of persistent poverty through planning, engineering, technical studies, or financial plans for projects.

September 21 Healthy Homes Production Grant Program. This HUD program takes a comprehensive approach to addressing multiple childhood diseases and injuries in the home by focusing on housing-related hazards in a coordinated fashion to address a variety of high-priority environmental health and safety hazards.

September 28 <u>Infrastructure and Capacity Building Challenge Grants.</u> National Endowment for the Humanities supports the design, purchase, construction, restoration, or renovation of facilities for humanities activities and the maintenance, modernization, and sustainability of existing digital scholarly projects and platforms.

September 27 <u>Agriculture Innovation Center Program</u> deadline. The USDA will make grants to Agriculture Innovation Centers that may be used by to provide technical assistance to help agricultural producers develop and market value-added agricultural products using a variety of options (except joint marketing efforts).

September 30 <u>Coastal Program</u> deadline. The U.S. Fish & Wildlife Service's Coastal Program is a voluntary, community-based program that provides technical and financial assistance to coastal communities, conservation partners, and landowners to restore and protect fish and wildlife habitat on public and private lands.

September 30 Endangered Species Recovery Implementation grant deadline. The objective of this U.S. Fish & Wildlife Service funding is to support the implementation of priority recovery actions for federally endangered and threatened species.

October 1 RISCA Arts Access Grantdeadline. Provides program support (maximum of \$3,000) to new ventures or occasional arts programs executed by non-profit organizations, or groups fiscally sponsored by a non-profit organization.
