Re: RI - FY 2013 - 2016 State Transportation Implementation Plan (STIP) Approval

Dear Governor Chafee:

The Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) have completed our review of the FY 2013-2016 Statewide Transportation Improvement Program (STIP) Amendment, which was adopted by the State Planning Council/Metropolitan Planning Organization for the State of Rhode Island on February 28, 2013.

In accordance with the 1990 Clean Air Act Amendments and 23 CFR § 450.324(b), a conformity determination does not need to be completed since projects in this amendment do not impact the previous conformity determination. Furthermore, we are making the following determinations:

- 1. The projects in the STIP are based on a planning process that substantially meets the requirements of Title 23, U.S.C., the Federal Transit Act and Subparts A, B, and C of 23 CFR 450.
- 2. The TIP is based on a continuing, comprehensive transportation planning process carried on cooperatively with the State, the MPO, and the transit operator in accordance with the provisions of 23 U.S.C. 134 and §5303 of the Federal Transit Act.
- 3. The STIP is determined to be in conformance with the State Implementation Plan for air quality requirements of 40 CFR Parts 51 and 93.

Accordingly, the FHWA and the FTA have jointly determined that the Rhode Island STIP Amendment is hereby approved. If there are any questions regarding this action, please feel free to contact Corey Bobba of the FHWA at 401-528-4577 or William Gordon of FTA at 617-494-3514.

Dear Ms. Melo & Mr. Berman:

The Transportation Advisory Committee approved Minor Amendment #1 to the State Transportation Improvement Program (TIP) for federal fiscal years 2013-2016 on February 28, 2012. This amendment was requested by the Town of Westerly. Since the most recent call for proposals for the FY 2013-2016 TIP, the Town has been working with the Watch Hill Conservancy to make significant upgrades to Westerly's historic Watch Hill commercial area centered on Bay Street. The goal of these upgrades is to provide for safer pedestrian mobility and lengthen the Bay Street commercial district operating season past the summer months.

The Town of Westerly and the Watch Hill Conservancy have each dedicated \$15,000 (total \$30,000) for the necessary architectural and engineering design to complete streetscape enhancements including restoring sidewalks to ADA standards, resetting curbing to restore the storm water gutter line, improving pedestrian lighting, roadway paving, installing new crosswalks, and providing sidewalk furnishing for pedestrians. The total cost of the proposed improvements is \$563,000.

In addition, the Town was awarded Community Development Block Grant disaster relief (CDBG-DR) funding in the amount of \$1.03 million for drainage improvements and repaying on Canal Street (Railroad Street to White

Rock Road) and White Rock Road (entire length). Repaving Canal Street (Railroad Street to High Street) was originally in the TIP for \$2.25 million (\$2 million in the Pavement Management Program and \$0.25 million in the Enhancement Program). The CDBG-DR funding will now complete some of the work that was already scheduled in the TIP.

The Town proposed to reduce the amount of funding in the Canal Street paving project by \$563,000 to \$1.69 million to reflect the CDBG-DR award. The Town also proposed that the Bay Street Infrastructure Project as outlined above be added to the TIP in the amount of \$563,000 in FY 2014.

This amendment was classified as a minor amendment which required a public hearing and final decision by the TAC with notice to the State Planning Council. The public hearing was held before the TAC on February 28, 2013. Staff has determined, and the Rhode Island Department of Environmental Management (RIDEM) concurs, that an Air Quality Conformity determination is not required, and the current analysis (completed for the FY 2013-2016 TIP) remains valid.

I hereby approve the amended TIP and provide my assurance that the TIP, this amendment, and any future amendments will satisfy all requirements of state and federal law, regulation, and guidance. I request that you provide the appropriate approvals and certifications so that the transportation projects contained in this TIP may proceed.

Enclosed are copies of the draft Transportation Advisory Committee minutes of February 28, 2013, the draft Public Hearing and Comment Period Report, documentation confirming fiscal constraint, a complete set of amended TIP Tables, and the air quality concurrence letter from RIDEM. I. Introduction

The State Planning Council received a request from the Town of Westerly for an amendment to the FY 2013-2016 Transportation Improvement Program (TIP). Since the most recent call for proposals for the FY 2013-2016 TIP, the Town has been working together with the Watch Hill Conservancy to make significant upgrades to Westerly's historic Watch Hill commercial area centered on Bay Street. The goal of these upgrades is to provide for safer pedestrian mobility and lengthen the Bay Street commercial district operating season past the summer months. The Town of Westerly and the Watch Hill Conservancy each dedicated \$15,000 (total \$30,000) for the necessary architectural and engineering design to complete streetscape enhancements including restoring sidewalks to ADA standards, resetting curbing to restore the stormwater gutter line, improving pedestrian lighting, finishing paving of the roadway, installing new crosswalks, and providing sidewalk furnishing for pedestrians. That design is nearing completion. The total cost of the proposed improvements is \$563,000.

In addition, the Town was awarded Community Development Block Grant disaster relief (CDBG-DR) funding in the amount of \$1.03 million for drainage improvements and repaving on Canal Street (Railroad Street to White Rock Road) and White Rock Road (entire length). Repaving Canal Street (Railroad Street to High Street) was originally in the TIP for \$2.25 million (\$2.0 in the Pavement Management Program and \$0.25 in the Enhancement Program). The CDBG-DR funding will now complete some of the work that was already scheduled in the TIP.

The Town proposed to reduce the amount of funding in the Canal Street paving project by \$563,000 to \$1.69 million to reflect the CDBG-DR award. The Town also proposed that the Bay Street Infrastructure Project as outlined above be added to the TIP in the amount of \$563,000 in FY 2014.

This amendment was classified as a minor amendment which required a public hearing and final decision on the request by the TAC with notice to the State Planning Council. The public hearing was held before the TAC on Thursday, February 28, 2013 at 6:30 p.m. RIDEM concluded that there was no need for an air quality redetermination as the project that is requested is air quality exempt.

B. Public Hearing Procedures

Ms. Shocket, Chair of the Transportation Advisory Committee (TAC) called the hearing to order at 6:35 p.m. and explained that Ms. Karen Scott, Assistant Chief of the Rhode Island Statewide Planning Program, will summarize the proceedings to date.

Ms. Amy Grzybowski, Director of Planning, Code Enforcement and Grants Enforcement for the Town of Westerly then presented the town's amendment request.

Ms. Scott then reviewed the hearing procedures prior to the acceptance of public comment.

Ms. Shocket explained that following the close of the hearing, the TAC will consider the proposal and the public comment received in deliberating their final decision.

Ms. Scott then thanked Ms. Shocket and explained the details of the Public Hearing:

- Amendment #1 for the TIP includes changes to the approved TIP that have been proposed by the Town of Westerly.
- In accordance with the Memorandum of Understanding between the Rhode Island State Planning Council, Department of Transportation, and Public Transit Authority, which outlines procedures for amending and modifying the TIP, this request has been classified as a minor amendment.
- The Amendment request was received by the Statewide Planning Program on August 28, 2012. The delay in processing the amendment stems from the need to update the State's Long Range Transportation Plan, *Transportation 2035* prior to amending the TIP. *Transportation 2035* was adopted by the State Planning Council on December 13, 2012.
- The Department of Environmental Management (RIDEM) has reviewed the proposal and agrees that an air quality redetermination is not required. RIDEM's written response was included in the TAC mailing packet.
- The required 10 day notice of the hearing and of the opportunity to submit comments was published in the Providence Journal on February 8, 2013 with electronic distribution to the State Planning Council, as well as posting on the Statewide Planning Program website.
- As of the start of this meeting, staff has not received any written comments.
- At the close of this public hearing, the Transportation Advisory Committee will act on this amendment. Their decision will be final. Notice of the decision will then be forwarded to the State Planning Council.

C. Town of Westerly Presentation

Ms. Scott introduced Ms. Amy Grzybowski from the Town of Westerly. Ms. Grzybowski then introduced Mr. Paul LeBlanc, Town Engineer and Mr. Richard Youngken representing the Watch Hill Conservancy, who joined her to explain Westerly's projects. They explained that the Town of Westerly has been working hard over the past couple of years to obtain as much grant funding as possible to support their infrastructure (see introduction above). They explained that federal Community Development Block Grant disaster relief (CDBG-DR) funding from Hurricane Sandy flooding will be used for drainage and repaving at Canal Street and White Rock Road. The remaining work for the Canal Street / White Rock project will be completed with TIP funds identified for FY 2016.

In addition to the Canal Street and White Rock Road projects, the Town has been working to advance an infrastructure project in the Bay Street commercial district. The Watch Hill Conservancy, Watch Hill Fire District, as well as the community, including the merchants, have also contributed to this effort by funding previous and desired work to locate the utility wires underground. The total public private partnership already invested, is approximately \$5.5 million. The Town's TIP amendment request relates to finishing the Bay Street project, with improving the appearance of the street including the sidewalks, proper infrastructure for utilities, and proper street amenities. The project is shovel ready.

D. Public Hearing Procedures for Speakers

Ms. Scott stated the following hearings procedures:

- This evening that this hearing is being held by the Transportation Advisory Committee to accept comments on draft Minor Amendment #1 to the State of Rhode Island's Transportation Improvement Program for fiscal years 2013 2016.
- The hearing will be conducted in accordance with the State Planning Council Rules of Procedure and the Administrative Procedures Act.
- Comments will first be received from those who have signed up on the registration forms available at the door, in the order in which they registered and after the customary recognition of elected officials.
- If you speak, please identify yourself and address all comments to the chair.
- To ensure that all who wish to speak may have an opportunity, each speaker will be limited to an initial presentation of five minutes.
- After all who wish to speak have had an initial opportunity, those wishing to make supplemental statements will be recognized.
- After all who have registered have spoken, any others wishing to comment will be recognized.
- Written statements will be given equal consideration. They may be read or simply submitted to me for the record. They must however be submitted prior to the close of this evening's hearing.

III. Public Hearing / Public Comment Summary

Ms. Shocket as chair & presiding officer asked if there were any elected officials who wished to present a statement. Since there were none, Ms. Shocket stated that she will now recognize any other speakers in order of their registration.

There were no public comments received during the public hearing on February 28, 2013.

IV. Conclusion

Ms. Shocket asked if there were any other comments. Since there were none, Ms. Shocket formally adjourned the hearing at 6:47 p.m. Ms. Shocket stated that a Public Hearing Report will be compiled by the Statewide Planning Program staff and made part of the record of these proceedings.

Following the Public Hearing, the Transportation Advisory Committee (TAC) resumed its meeting and discussed the proposed FY 2013 – 2016 TIP Amendment #1. (See TAC Meeting Minutes of February 28, 2013.) The TAC voted unanimously to approve TIP Amendment #1 as requested.

My office agrees that the proposed changes are "air quality exempt", and as such, the current air quality conformity determination will remain valid.

Dear Mr. Flynn,

On behalf of the Town of Westerly I am requesting an amendment to the 2013-2016 TIP that was recently approved by the State Planning Council. Due to our success in receiving grant funding from Community Development Block Grant – Disaster Relief and Economic Development Agency awards for the Canal Street Infrastructure Improvement Project we are in a position to reallocate funds to The Bay Street Infrastructure Project.

The entire Bay Street area is a concentrated walkable historic commercial area that is an important economic engine for the Town of Westerly and the region. It is listed in the National Register of Historic Places and it is a key regional destination. With the remaining proposed improvements, it is the hope of the Town that the operating season will be extended from Labor Day to the New Year with a new spring opening date of March 1st each year. This will provide jobs and commercial activity for 10 months of the year rather than 5 months of the year.

The Bay Street project has been a Public/Private Partnership between the Watch Hill Conservancy and the Town of Westerly from its inception with design and construction costs shared by both entities. Much of the design and underground infrastructure construction is substantially complete with the exception of streetscape enhancements: restoring sidewalks to ADA standards, resetting curbing to restore the stormwater gutter line, improving pedestrian lighting, finish paving of the roadway, installing new crosswalks, and providing site furnishings such as benches as resting places for pedestrians. A primary goal of the enhancement project is to provide safer pedestrian mobility to this destination main street. The enhancement project will substantially complete a major overhaul of the street's basic infrastructure. The streetscape enhancement project has been in the design phase and will be shovel-ready this fall. Streetscape improvements that are included in the Town of Westerly's TIP amendment submission must be completed by May 1, 2013 so as not to negatively impact commerce and tourism in the historic waterfront for the high season of 2013 and as a cost-effective continuation of planned street work. As such, it is critical that the State Planning Council approve the TIP amendment at its September 2012 meeting, and that RIDOT commit to the requested \$563,000 funding by November 2012. This will allow the necessary time for the Town to have its street enhancement plans and specifications finally reviewed and publically bid for construction to commence as early in the spring of 2013 as the weather permits.

The Town of Westerly and the Watch Hill Conservancy respectfully request the reallocation of \$563,000 from the Canal Street/ White Rock Pavement Management Program and Canal Street/ White Rock Enhancement Program to complete the Bay Street project

The overall amount for the project completion is \$593,000 with the remaining \$30,000 being spent on design and on the Watch Hill Conservancy's co-management which will have been committed prior to the grant award, and is not eligible for TIP funds. The cost breakout is for construction of new sidewalks and curbing (including demo) is \$280,000; crosswalks at \$35,000; street lighting (including wiring at \$92,000) is \$208,000; street furnishing and signage \$25,000; Architectural and Engineering (covered by the Town and Watch Hill conservancy and not included in the TIP request, but included in the above budget) \$30,000; and Architectural and Engineering for the Town's project management and lighting design consultant \$15,000.

Town of Westerly Bay Street Infrastructure Project TIP Amendment Application Additional Information

1) Mobility benefits

As the main street of Watch Hill's harbor front and the principal commercial street in Watch Hill, Bay Street is not adequately described with 4400 trips as an average daily use guide. The street is heavily used in four months of the summer season and only lightly to moderately in use in the other eight months. The use during the summer may climb to over 13,000 trips per day. Bay Street functions not only as a commercial main street, but also as an urban collector as defined by RIDOT and Statewide Planning.

The Bay Street project will enhance Bay Street's level of service for vehicles only slightly from existing because the project is basically a street infrastructure rehabilitation project using the same alignment and width. However significant improvements will be made to curbing, sidewalks and additional crosswalks, pedestrian lighting, and landscaping, improving the level of service for pedestrians, including ADA access.

The Bay Street area provides multimodal and intermodal transportation opportunities for pedestrians, bicyclists, motorists, and boaters. Ferry service has linked the area to Connecticut and Downtown Westerly; jitney bus service now links Watch Hill to Downtown Westerly, Misquamicut, and other Westerly shore areas. Key destinations on Bay Street include commercial retail, condominium residences, summer cottages, hotel accommodations, restaurants, yacht harbor piers and moorings, the historic Merry-Go-Round, public and private beaches, and the Napatree Point Conservation Area.

The regional impact of the project lies in Watch Hill's economic role as one of a cluster of tourist destinations in southern Rhode Island and nearby southeastern Connecticut. This cluster includes Misquamicut, Weekapaug, Downtown Westerly/Pawcatuck, Stonington Borough, Mystic, and the Mashantucket-Pequot, and Mohegan casinos. Upgrading Watch Hill's main street contributes to the appeal of the entire two state region as a tourist destination.

The mobility of the Bay Street waterfront area will be considerably enhanced by pedestrian-related improvements. Better sidewalks, crosswalks, curbing, and street-paving will add to easier and safer pedestrian and vehicular movements and parking arrangements including convenience and user comfort.

2) Cost effectiveness

The Town of Westerly and the project collaborators (the Watch Hill Fire District and the Watch Hill Conservancy) have chosen to improve as much of the street infrastructure as possible. Work is already underway for storm drainage improvements and new water service. Curbing, crosswalk and sidewalk upgrades are extremely cost effective if undertaken at this time. Advocates project a 40% cost savings over a piece-meal project. Although the entire infrastructure beneath the street will be replaced, new sidewalks and historic granite curbing will significantly upgrade the street. Current sidewalk condition is uneven and dangerous in some areas.

Private funding sources have already been leveraged to support engineering and design, and commitments for additional funding from private sources have been secured by the Watch Hill Conservancy, Watch Hill's environmental and historic preservation advocate. The project has been scaled back and broken into funding and construction phases to reduce costs and disruption during the busy summer season.

3) Economic development

It is anticipated that this *shovel-ready* project will spur reinvestment in Bay Street commercial properties, including a projected \$52 million in rehabilitation and new construction that could generate over 1492 short term direct effect jobs (based upon the RIMS II multipliers for construction). The long term result for the area would be 181 direct effect, local work force-appropriate jobs. Five new and significant private development projects have been contemplated for the street.

Long term Bay Street employment would benefit from sustaining 500-650 current jobs in retail, real estate management, accommodation, and hospitality, while adding approximately 130 jobs in the project area to the current market mix. The project area is within a designated Urban Services Area designated by *Land Use 2025* (adopted by the State Planning Council in 2006), and is a key component of a larger regional economic development initiative for the town of Westerly and the coastal region which builds upon existing assets and the local work force. It will be a catalyst for redevelopment in historic downtown Westerly and other nearby shore communities with alternative transportation linkages such as trolley, jitney, and water-based service.

Town of Westerly Bay Street Infrastructure Project TIP Amendment Application Additional Information

The rebuilding of out-of-date and collapsing public works infrastructure will provide an incentive and climate for local investment and growth in area small-medium main street-type businesses located on Bay Street. The average size of most businesses affected by the project is less than 4 employees. These are micro-small retail businesses which provide seasonal tourism-related employment at low-mid range wages. Extending the season to 9-10 months is one of the project goals and a trend in the region. Rhode Island's strategic plan for development of the tourism industry support heritage and cultural tourism through marketing campaigns, support of private and public investments in historic preservation, the arts and culture, as well as supporting world-class recreational venues in which Rhode Island has a distinctive association and market niche: golf, tennis, sport-fishing, and sailing. In addition, Bay Street offers access to world class coastal conservation areas attracting shoulder season activities and eco-tourism. Public infrastructure improvements are seen as critical to long term privately-financed investments in this industry as well as expansion to a 12-month season.

4) Environmental impact

While the project does not improve air quality, it does not increase air pollution in the area. It does promote future energy conservation by providing new infrastructure for water lines (reducing leakage and failure), and utilities (insulating electrical wires in a duct bank reducing energy leakage). A major improvement in water quality will result from the upgraded storm water drainage system with its subsurface detention basins. The current collapsed system, built in the early 20th century, has no storm water treatment and discharges directly to the harbor. Consequently, the project seeks to protect and enhance the environmental resources of the area while decreasing the potential of financial loss from storm events.

The project area is located within the Watch Hill Historic District listed in the National Register of Historic Places. The area is also listed in the RIDEM inventory of scenic areas. The visual appearance of Bay Street will be considerably improved with paving, curbing, sidewalk, crosswalk and street lighting upgrades. The project will improve the walkability of the area and contribute to the vitality of Watch Hill's village center. Bay Street and the harbor front are key historic components of this area. The project has already received a conditional approval from the Rhode Island Historical Preservation and Heritage Commission (RIHPHC).

5) Degree of Support

Community support for this project has been expressed in a community survey undertaken for the update of Westerly's comprehensive plan (2009-10) in which a majority approved of promotion and enhancement of the town's environmental, recreational, historic preservation and scenic assets. Further support is indicated by passage of a municipal bond to fund the project in 2010. In initiating design for the project in 2010, and construction in 2011, the Town has given priority to the project.

Private partners in the project (the Watch Hill Conservancy, and the Watch Hill Fire District) undertook feasibility study and design efforts in 2008, demonstrating a significant past commitment. These local partners have collaborated with the Town on design issues, funding, bidding, and project management.

The project is located within a state-designated Urban Services Area and complements local and state comprehensive planning efforts to invest in existing neighborhoods and commercial districts to enhance and grow economic development opportunities. This smart growth policy is particularly appropriate for National Register-listed historic districts such as Watch Hill which serve as key cultural heritage and eco-tourism venues within the state's tourism management plan.


6) Safety and Security

Bay Street's sidewalks and crosswalks have not been addressed for a considerable time and evidence suggests piece-meal corrections of some deficiencies over time. The sidewalks are not ADA accessible due to curb barriers and uneven pavement. Crosswalks are not well defined and are limited in number. In some cases they do not correspond to key crossing points. The Bay Street project will create ADA access and additional crosswalks, improving pedestrian access and walkability in the area. The removal of Utility poles which constrict and block sidewalks will enhance ADA access on Bay Street's sidewalks and create a safer pedestrian zone. Non-point pollution in storm water runoff will be collected and treated appropriately and new drinking water lines will be installed – both improvements will add to public health and safety.
