# **Quonset Freight Field Trip**

State, local, and private-sector freight partners participated in a Statewide Planning event on October 19 at Edesia, a company located in the Quonset Business Park, to learn about the impact freight movements have on the community and the importance freight companies have on the local and state economy.

Edesia is a non-profit social enterprise founded in 2010 that produces specialized foods targeting different stages of malnutrition. Their main product ("Plumpy'Nut") does not need water or refrigeration and can be administered at home. It is nutritionally-dense and can rehabilitate a malnourished child under the age of five in just eight weeks. The factory produces 1.3 million pounds of product that reaches 69,000 children worldwide every week. Since 2010, the company has sent their product to sixtyfive countries and has helped twenty-two million people.

Edesia staff took the group on a tour of the factory and explained the many quality control measures they take, as well as the logistical freight issues they have while shipping their products from Quonset to Africa and other continents. Tour members were also able to sample Plumpy'Nut at the conclusion of the tour, and found it to be very tasty!

The goals of the municipal freight field trips are to give municipal staff, Freight





to help develop a greater capacity to address freight issues through shortrange and long-range planning.

These trips and tours provide an opportunity for planners to connect directly with some of the state's largest freight generating companies and facilities.

### **Technical Assistance Winner Announced**

In late August, the Division of Statewide Planning launched our 2023 Municipal Technical Assistance Program solicitation, seeking applications from municipalities interested in support for planning projects that enhance active transportation opportunities, increase mobility choice, and promote walkability and bike-ability of neighborhoods.



After reviewing applications from six municipalities, we are pleased to announce that

the City of East Providence has been chosen for assistance for their application to create a "Citywide Comprehensive Bicycle and Pedestrian Plan." East Providence has identified a connected citywide bicycle and pedestrian network as a priority in the transportation element of their current draft Comprehensive Plan update. A connected bicycle and pedestrian network is also a priority for the city in coordination with other ongoing planning efforts to connect the East Bay Bike Path, the Ten Mile River Greenway Bike Path, and the planned separated bicycle and pedestrian infrastructure for the Henderson Bridge redesign.

Most residents in East Providence rely on single-occupancy vehicles for their primary means of transportation, in part due to a lack of detailed comprehensive planning of safe, on-street, dedicated bicycle facilities and well-connected, high-quality ADA-compliant sidewalks for pedestrians. Statewide Planning's assistance will provide a consultant for a planning process to bring together residents, businesses, non-profits,

and government to dig deep and discuss the ways that East Providence's transportation network can be re-imagined for the future. We look forward to working with the city to make active modes of transportation safer, more convenient, and more readily accessible!

# **Grants & Deadlines**

**November 3** <u>Carbon Reduction Strategy Plan</u> deadline for submitting comments to help RIDOT strategize how to reduce greenhouse gas emissions in the state's transportation sector.

**November 6** Pathways to Removing Obstacles to Housing (PRO Housing) supports communities to remove barriers to affordable housing, such as outdated zoning, land use policies, or regulations or gaps in available resources for development (new deadline).

**November 7** Healthy Homes Production Grant Program takes a comprehensive approach to addressing childhood diseases and injuries by focusing on low-income housing-related hazards in a coordinated fashion.

#### November 13 Various EPA Brownfield Grants' deadline:

- Assessment Coalition Grants fund one "lead" eligible entity to partner with two
  to four eligible entities that do not have the capacity to apply for and manage
  their own EPA cooperative agreement.
- <u>Cleanup Grants</u> provide funding to carry out cleanup activities at one or more brownfield sites.

- <u>Community-wide Assessment Grants</u> provide funding to inventory, characterize, assess, conduct a range of planning activities, develop site-specific cleanup plans, and conduct community engagement related to brownfield sites.
- <u>Multipurpose Grants</u> fund a range of eligible assessment and cleanup activities, including planning and additional community engagement activities.

**November 13** Community Placemaking Grants from the Project for Public Spaces enable nonprofits and government agencies to address inequality of access by working with local stakeholders to transform public spaces or co-create new ones.

**November 14** AmeriCorps State and National American Rescue Plan Planning Grants provide support to develop a program that will engage AmeriCorps members in implementing evidence-based interventions to solve community problems.

**November 15** <u>Dangerous by Design Technical Assistance Program</u> will equip local champions with knowledge of data and trends around traffic safety, how to incorporate data into local actions, and how to increase support of safer streets for all road users.

**November 15** <u>Inspire! Grants for Small Museums</u> support project-based efforts to serve the public through exhibitions, educational programs, digital learning resources, and community outreach.

**November 15** <u>Thriving Communities Grant letter of interest</u> deadline for disadvantaged/transportation-insecure communities adversely affected by environment issues or climate to comprehensively plan for quality community development projects.

**November 17** NOAA's Transformational Habitat Restoration and Coastal Resilience Grants support habitat restoration projects that restore marine, estuarine, or coastal ecosystems using approaches that enhance community/ecosystem resilience to climate hazards.

**November 22** <u>Meat and Poultry Processing Expansion Program- Phase 2</u> provides USDA funding to meat and poultry processors for new facilities and for the renovation and expansion of existing facilities.

November 24 <u>Community Facilities Technical Assistance and Training Grant - Disaster Relief Supplemental Appropriations Act 2023 Grant</u>funds provide technical assistance to repair essential community facilities in rural areas that were damaged by <u>Presidentially-declared major disasters</u> in calendar year 2022.

**November 30** <u>Landscape Scale Restoration</u> from the USDA Forest Service provides funds for science-based restoration of priority rural forest landscapes.

**November 30** <u>Local Agriculture and Seafood Act (LASA) Grants Program</u> provides grants that directly benefit and strengthen the local food system in Rhode Island.

**December 1** Rhode Island Council for the Humanities Major Grants intent to apply deadline for grants (\$2,000+) in support of public projects and documentary film/media projects that will begin after April 1, 2024.

**December 6** <u>RIDEM Outdoor Recreation grant program</u> provides matching funds to cities, towns, and recognized tribes for the acquisition, development and renovation of outdoor recreational lands and facilities.
