Statewide Planning is 60!



The RI Division of Statewide Planning is celebrating our sixtieth birthday this year!

Created in 1964 as the "Rhode Island Statewide Planning Program in the Division of Planning," the office was established by Chapter 42-11 of the RI General Laws as the central planning agency for state government. The work of the Program is guided by the

State Planning Council, comprised of state, local, and public representatives and federal and other advisors.

The stated objectives of the Program are: "to prepare strategic and systems plans for the state; to coordinate activities of the public and private sectors within this framework of policies and programs; to assist local governments in management, finance, and planning; and to advise the Governor and others on physical, social, and economic topics."


As well as serving as the state's land use planning office, Statewide Planning is also the state's sole <u>metropolitan planning organization</u> (MPO). In 1974, Rhode Island Governor Philip W. Noel designated the State Planning Council as the MPO, which was affirmed by Governor Bruce Sundlun in 1992. Dan Varin was the first Associate Director of Statewide Planning and led the office from shortly after its creation until his retirement in 1996.

MPOs were created by the Federal-Aid Highway Act of 1962 as a reaction to urban highway projects that often destroyed housing and local communities, particularly those belonging to people of color or low-income persons. States were required to form an MPO for any urbanized area with a population greater than 50,000 to ensure local cooperation in transportation planning and to provide "cooperative, comprehensive and continuing" multimodal planning for urban areas. As one of over four hundred MPOs in the U.S., we are required to undergo a recertification review by FHWA and the Federal Transit Authority every four years.

Upcoming Partial Solar Eclipse

You have most likely heard by now that on April 8, 2024, a solar eclipse will traverse from Mazatlán, Mexico to Newfoundland & Labrador, Canada. The path of totality (or the area where the sun will be one hundred percent blocked) during this eclipse will be to the north of Rhode Island, passing through Burlington, VT, Lancaster, NH, and Caribou, ME around 3:30PM. Those of us south and north of the path of totality will see a partial eclipse, which will still be a sight to behold (with the proper eye protection, of course).



On April 8, the eclipse should begin at 2PM and end at approximately 4:30PM. Statewide Planning's Supervising GIS Specialist Garth HoxsieQuinn says, "As this is during the beginning of afternoon rush hour traffic, you should plan travel accordingly. For Rhode Island, approximately ninety percent or more of the sun will be blocked and, while this is not a total eclipse, it should still be a spectacular show, weather permitting!" The website timeanddate has animation of

what the eclipse will look like in the Providence area.

Viewing the solar eclipse should be done in a way that will protect your eyes from harm. The <u>American Astronomical Society</u> has a page dedicated to safely viewing the upcoming solar eclipse, with a link to suppliers of solar viewers and filters and instructions on how to safely view the eclipse with and without proper viewers/filters.



Remembering Dr. Marcia Marker Feld

Longtime University of Rhode Island Community Planning Professor Marcia Marker Feld passed away on March 16, 2024. She was 89 years old.

Born and raised in Brooklyn, Marcia was the first woman to earn a PhD in urban planning from Harvard University. She graduated from Brooklyn College in 1956 and went on to get a master's degree from the University of Pennsylvania before earning a PhD in city planning from Harvard University in 1973. From 1972 to 1975, she ran the Metropolitan Planning Project, helping to desegregate Boston schools.

After earning her PhD, Dr. Feld began teaching at the University of Rhode Island, where she served as chair of the Graduate Department of Community Planning and Area Development (CPAD) and executive director of the URI Urban Field Center in Providence. She continued to teach at the University of Rhode Island until her retirement in 2008, when she was named emerita. The following year, the university created a lecture series in her honor.

Marcia received the "Lifetime Achievement Award for Campus-Community Partnerships" from the Office of University Partnerships, U.S. Dept. of Housing and Urban Development in 2004. The Association of Collegiate Schools of Planning annually gives the Marcia M. Feld Leadership Award to recognize outstanding women leaders in their organization.

Many planners educated in Rhode Island were impacted by Marcia's fierce determination to both "do good and be right" and to "remember who your client is," whether they met her in the classroom or at the Urban Field Center. Planning education in RI was richer for having Dr. Feld as CPAD Chair, a professor teaching planning theory, and as a woman who really cared about the students and the program.
